Lacombe County is seeking a dedicated and hands-on **Assistant Construction Supervisor** to play a pivotal role in helping to coordinate the daily operations of our road construction team and projects (from start-up to final reclamation, and everything in between).

As a working supervisor, you will be at the forefront of the daily operations, overseeing the road construction team members and ensuring efficient and safe coordination of the construction tasks.

We're seeking an individual with experience in road construction, heavy equipment operation and leadership.

Key Responsibilities

- Assist the Construction Supervisor in the planning, scheduling, and coordination of the construction
 activities and projects. This includes project start-up (assisting in design work, working with landowners,
 coordinating utility moves, obtaining regulatory approvals, overseeing the final reclamation, etc.).
- Assist in coordinating and managing the day-to-day operations of the construction crew. Provide handson leadership and foster a positive and collaborative work environment, identify training needs and provide direction to the employees.
- Provide assistance in developing grade plans and utility coordination. Interpret road construction grade plans and make adjustments as needed based on onsite conditions.
- Operate the pieces of heavy equipment during peak periods, holidays, and leaves of absences, ensuring uninterrupted progress on our projects.
- Monitor construction activities to ensure workmanship meets quality standards and complies with regulatory requirements, safety standards, and project objectives and is within budget.

Key Qualifications

- A minimum of 3-5 years of hands-on experience in construction, with a focus on road construction
 projects, and proficient with the operation of various construction equipment. A good working knowledge
 of municipal road building is preferred. Experience with Provincial and Federal regulations and best
 practices as they relate to road construction activities would be considered an asset.
- Proven ability to lead and supervise construction teams effectively, ensuring tasks are completed on time, within budget, and safely.
- Strong technical proficiency in construction methodologies, grade plans and utility coordination. Able to interpret and adjust construction plans as needed. Demonstrated ability to analyze and resolve construction related issues, adapting to various onsite conditions.
- Valid Class 5 Driver's License, with an acceptable driver's abstract is required upon hire. This is a safety sensitive position; the successful applicant will undergo a pre-employment drug and alcohol test.
